

Terms and Conditions

Festive Laptop Promotion (the “Promotion”)

1. Eligibility

- 1.1. This Promotion is only open to new students (“Eligible Students”) who enroll in designated programs at Eton College Canada Inc. and Taylor Pro College Ltd. (the “Colleges”) between December 1, 2024 through January 31, 2025. The designated programs include Flight Attendant Preparation Program, Travel and Tourism, Addictions and Community Support Worker, and Social Services Support Worker (the “Designated Programs”).
- 1.2. The Promotion is available to Eligible Students resident in Canada, with the exception of residents of Quebec.
- 1.3. There is no maximum number of Eligible Students for this Promotion.

2. Promotional Offer

- 2.1. Eligible students will receive one (1) free laptop computer (each a “Laptop”) upon payment of their tuition to the Colleges as set out in Section 3 herein. The Laptop will be either Dell, HP, or Lenovo with the following configuration: Core i3, 4GB, 500gb with Windows 10.
- 2.2. The Laptop becomes the property of the Eligible Student upon delivery and does not need to be returned to the Colleges at the end of the Designated Program.

3. How to Participate

- 3.1. To participate in the Promotion, Eligible Students must enroll in one of the Designated Programs between December 1, 2024 and January 31, 2025 and be accepted into the Eligible Student’s selected program based upon the current admission requirements of the Colleges.
- 3.2. Eligible Students who are not applying for financial aid will be shipped the Laptop within 10 business days after signing the enrollment contract, paying the initial tuition payment to the College, completion of orientation, and attending regular classes at the College for one week.
- 3.3. Eligible Students who are applying for financial aid will be shipped the Laptop within 10 business days after the Notice of Assessment is received by the College, confirmation of Enrollment has been received, completion of orientation, and attending regular classes at the College for one week.
- 3.4. If a student wants to start early, the student can make an upfront tuition payment of CAD 1000, start class while waiting for his NOA and get a laptop.
- 3.5. The Laptop will be delivered to the address for delivery provided by the Eligible Student. The costs of delivery shall be the responsibility of the Eligible Student and must be paid to the supplier of the Laptop prior to shipping.

4. Limitations and Restrictions

- 4.1. This Promotion is valid only for the specified enrollment period (December 1, 2024 to January 31, 2025) and for new students only. Existing students of the Colleges are not Eligible Students.
- 4.2. The Promotion is limited to one Laptop per Eligible Student.
- 4.3. The Laptop model and specifications will be determined by the Colleges and may vary based on availability from the supplier.
- 4.4. This Promotion cannot be combined with any other promotions, offers, or discounts offered by the Colleges and has no cash value.
- 4.5. Upon delivery of the Laptop to the Eligible Student, the Laptop shall be deemed the sole and exclusive property of the Eligible Student. No returns or exchanges shall be accepted by the Colleges.

5. General Conditions

- 5.1. The Colleges are not responsible for any technical malfunctions or human errors that may occur in the administration of this Promotion.
- 5.2. Each Laptop will come with a one (1) year comprehensive warranty from defects and workmanship provided by the supplier. Warranty claims shall be directed by the Eligible Students to the supplier and all warranty work shall be completed at the location of the supplier.

5.3. All decisions made by the Colleges regarding this Promotion are final and binding. The Colleges reserve the unfettered right to modify or terminate the Promotion at any time without notice

6. Privacy and Data Protection

6.1. Personal information collected in connection with this Promotion will be used in accordance with the College's Privacy Policy.

7. Governing Law

7.1. This Promotion and these terms and conditions are governed by the laws of British Columbia, Canada.

7.2. Any disputes arising from this promotion will be subject to the exclusive jurisdiction of the courts of the Province of British Columbia.
